



# Terms and Conditions Applicable to the Invictus Test Series (CBT Mode)

### 1. General Instructions:

- 1. The Invictus Test Series (CBT Mode) will be conducted through authorized CBT Centres managed by Aakash Invictus in collaboration with approved service providers.
- 2. Candidates must appear for the test only at the centre, date, and time mentioned on their Hall Ticket.
- 3. Entry to the test centre will be allowed **only with a valid Hall Ticket and a government-issued photo ID proof.**
- 4. The **Hall Ticket is non-transferable** and must be presented at the time of entry.

#### 2. Test Conduct & Behaviour:

- 1. Candidates should report to the test centre at least 30 minutes before the scheduled start time.
- Entry will not be permitted after the gate closing time mentioned on the Hall Ticket under any circumstances. Any candidate reporting after the gate closing time will not be allowed to appear for the examination.
- 3. No candidate will be allowed to appear at the Examination Centre on the date and shift/time other than that allotted to them on their Admit Card.
- 4. Any act of forceful entry, argument, or representation with the exam functionaries by such candidates will be treated as an Unfair Means (UFM) activity and may result in cancellation of candidature and debarment from future examinations.
- 5. **Mobile phones, smartwatches, calculators, or any electronic gadgets** are strictly prohibited inside the exam hall.
- 6. Any form of **unfair means, malpractice, or impersonation** will lead to immediate disqualification and cancellation of candidature.
- 7. Candidates must **follow the invigilator's instructions** throughout the test. Violation of instructions will result in disciplinary action.
- 8. The candidates are advised to read the instructions on the Admit Card carefully and strictly follow them during the examination.

### 3. Technical Guidelines:

- 1. The test will be conducted in **Computer-Based Mode (CBT)** only. Each student will be assigned a computer system with login credentials at the centre.
- 2. Candidates must verify that their **Name** and **PSID** displayed on the computer screen are correct before starting the test.
- 3. Any technical issue should be immediately reported to the invigilator or centre supervisor.
- 4. Tampering with the computer system, test interface or attempting unauthorized access will result in disqualification.





## 4. Test Timing and Submission:

- 1. The duration of the test will be as specified in the Hall Ticket.
- 2. The timer on the screen will automatically close the test once the allotted time is over.
- 3. Candidates must click on **"Submit"** after completing their test to ensure their responses are recorded.
- 4. Leaving the test centre without submission may lead to non-evaluation of the paper.

#### 5. Result and Evaluation:

- 1. Results will be declared on the official portal after completion of all test sessions.
- 2. The decision of Aakash Institute regarding **evaluation**, **scoring and result declaration** shall be final and binding.
- 3. In case of any discrepancy in the result, students must raise the concern within 48 hours of result declaration.

## 6. Conduct and Disqualification:

- Any candidate found involved in cheating, copying, disruptive behaviour, or damaging centre property will be immediately disqualified.
- 2. The management reserves the right to **cancel the candidature or result** of any student violating the test rules.

## 7. Liability Clause:

- 1. While every effort will be made to ensure smooth conduct, Aakash Institute shall not be responsible for **technical failures**, **power outages**, **or unforeseen disruptions** beyond its control.
- 2. No request for re-test or compensation will be entertained under such circumstances.

## 8. Declaration and Acceptance:

By registering for and appearing in the Invictus Test Series (CBT Mode), the candidate acknowledges that:

- All information furnished is true and correct.
- He/She has read, understood, and agreed to abide by the above rules and conditions.
- Any violation of these terms will result in cancellation of candidature or result.
